Dear Potential Teen Miss Rodeo South Dakota Contestant,

On behalf of Miss Rodeo South Dakota, Inc., thank you for your interest in the 2024 Teen Miss Rodeo South Dakota Pageant.

The pageant will be held October 31-November 2, 2024, in Brookings, SD in conjunction with the Brookings PRCA Rodeo produced by Sutton Rodeo Company. The Brookings Inn will serve as our host hotel with a block of rooms held through October 31 under MISS RODEO SD PAGEANT. Rates are as follows: \$85.99 + tax for Wednesday and Thursday night, then it goes up to \$89.99 + tax for Friday and Saturday night. Family and friends are welcome to make reservations under this block. Contestants' rooms will be provided for Thursday, Friday, and Saturday.

This file includes all of the application information needed to compete, as well as the Teen Miss Rodeo South Dakota Pageant Rulebook, tentative pageant schedule, sample resume, pageant program advertising information, and a copy of the contract you will be required to sign if you are selected TMRSD. Please read and complete each document carefully. Note on page 5 of the rulebook that TMRSD contestants must hold MRSDI membership, for liability purposes. This is in addition to the pageant registration fee. Use the included checklist to make sure all necessary documents and materials are completed or included and postmarked by *September 6, 2024*. I strongly encourage choosing a shipping method that includes tracking and insurance, and please mail checks rather than cash.

"Bags for Bucks" Purse Auction Information

Unlike at the Miss Rodeo America pageant our "Bags for Bucks" event will not be a judged category but will be for fun and fundraising purposes only during the fashion show. Focus is to be on the bag. The bag can be vintage or new. The bag does not need to contain any items, but if you choose, any additional items must be fully contained within your bag. Any gift certificates must have an expiration date printed on the certificate, as well as full contact information for whoever is honoring the certificate. Max size of bag can be no greater than 62 linear inches, including wheels and handle- to determine linear inches total length plus width plus height.

Ideas for what your bag may include, but not limited to: handbag, clutch, briefcase, garment bag, diaper bag, suitcase, duffel bag, backpack, rope can, bridal bag. Bag and contents must be delivered to Miss Rodeo South Dakota Pageant representative upon move-in. Items may be added to your bag after the form is submitted with your application materials, but neither description nor the value may change. Items cannot be removed from your bag once the description is submitted. We encourage you to post your purse description on your personal Facebook, Instagram or Twitter and website to promote your purse. The purse auction will take place during the pageant fashion show and proceeds will be used for Miss Rodeo South Dakota, Inc. events. Suggested value range: \$100-150.

Teen Miss Rodeo South Dakota Contestant Release & Waiver of Liability

By my signature on this application, I hereby certify that I have received and read the regulations governing the Teen Miss Rodeo South Dakota Pageant in the Teen Miss Rodeo South Dakota Official Rule Book. (herein called the regulations) which is incorporated by reference; that my conduct as a pageant contestant will be in strict accordance with the regulations established by Miss Rodeo South Dakota, Inc. (hereinafter called MRSDI); that I acknowledge these regulations will prevail and govern my actions throughout all pageant programs, activities, and functions. To be eligible to compete for Teen Miss Rodeo South Dakota, applicants must meet all the eligibility requirements set forth below:

- 1. Age: I was at least 13 years of age and not older than 18 years of age as of January 1st of the current year. I will provide a copy of a government issued identification (such as a birth certificate, driver's license, or passport) to verify my age.
- 2. U.S. Citizen: I am a citizen of the United States.
- 3. Resident of the State: I am a legal resident of South Dakota.
- 4. Gender: I am a female and have always been a female.
- 5. Marital Status: I am not currently married and have never been.
- 6. Parental Status: I am not a parent of any child and I am not and have never been pregnant.
- 7. Good Character: I am of good moral character. I have never committed or been involved in an act of moral turpitude.
- 8. No Criminal Record: I have not been convicted of any state or federal misdemeanors or felony offense. As used herein "convicted" means a finding of guilt, a guilty plea, a plea of no contest, a plea of no nolo contendere, a judgement of conviction even though the court suspended execution of a sentence, or a deferred imposition of a sentence. The term does not include the finding of guilt which is reversed on appeal, an offense classified as a criminal infraction, or minor traffic offenses. Subject to background check by MRSDI.
- 9. Health: I am in good health, and I do not have any health concerns which would prevent me from fully participating in this contest or from serving as Teen Miss Rodeo South Dakota, if selected.
- 10. Substance Abuse: I do not use any illegal or controlled substances (other than prescription medications and then only in the manner prescribed). I do not abuse alcohol or any other dangerous substances.
- 11. Contractual Obligations: I am not under any contractual obligation which would interfere with my ability to participate in this contest or interfere with my ability to perform as Teen Miss Rodeo South Dakota.
- 12. I have not previously held the title of Teen Miss Rodeo South Dakota.
- 13. No Subsequent Competitions: If selected, I will not compete in or otherwise participate in any other beauty or talent contest, pageant, or activity in my term as Teen Miss Rodeo South Dakota, unless approved by the MRSDI Board of Directors.

- 14. No other acts detrimental to reputation: I have not engaged in any act, which if made public, would be reasonably likely to cause harm or damage to my reputation or to the goodwill and reputation of Teen Miss Rodeo South Dakota. If I have any concerns about the applicability of this provision, I acknowledge I have been advised to discuss this with a representative of MRSDI prior to signing this form.
- 15. Ability to Perform: To the best of my knowledge, there is nothing that will interfere with my ability to compete in this contest or to perform the obligations of Teen Miss Rodeo South Dakota if selected.
- 16. Use of my own horse: I understand that MRSDI is not responsible for the care or wellbeing of the horse that I must provide for myself to participate in this pageant.

By signing below, I verify that I meet all the eligibility requirements set forth above.

I hereby release all rights, title, and interest to photographs and/or public relations material involving myself to MRSDI for use in pageant promotion.

I agree that the judges' decisions are final and that the pageant scores will be held confidential by an independent certified public accountant, and that such scores will not be available to me or any other contestant.

I understand that failure on my part to disclose material or information to MRSDI officials or the making of false material statements will automatically disqualify me from participating in any pageant, and that scholarships or prizes of any kind, which I may receive as a result of my participation, must be returned to MRSDI. In the event that I am disqualified by MRSDI, I hereby release MRSDI from any or all liability for the disqualification under the same terms of release stated below.

I understand that this activity involves certain risks for physical injury. I also understand there are potential risks of which I may not presently be aware. Because of the dangers of participating in this activity, I recognize the importance and agree to fully comply with applicable laws, policies, rules and regulations, and any instructions from MRSDI officials regarding participation in this activity. I understand that MRSDI does not insure participants in the above described activities, that any coverage would be through personal insurance, and MRSDI have no responsibility or liability for injury resulting from this activity. I voluntarily elect to participate in this activity with knowledge of the danger involved, and I hereby agree to accept and assume any and all risks of property damage, personal injury, or death.

In consideration for the opportunity to voluntarily participate in the Teen Miss Rodeo South Dakota Pageant, I agree to release and fully discharge MRSDI, its officers, managers, members, agents, representatives, successors, sponsors, stock contractors and assigns from any and all liability to me, my family, my business, or my heirs, personal representatives, successors or assigns for damages or other relief on account of any claim or cause of action that I have now or may have in the future, whether I know it or not, whether such claims or causes of action have not matured or not, arising out of competing in the Teen Miss Rodeo South Dakota Pageant.

I further agree, in consideration of the above-described opportunity, not to sue any of the persons or companies that I have released for any liability on any claim or cause of action from which I have released them herein. I expressly agree that this Release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of South Dakota, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

I certify that the above information is given freely and is true and accurate. MRSDI and its agents are authorized to verify any information contained on my application and to conduct a criminal background check. I understand MRSDI may rely on information furnished by me, and I agree that if any information contained herein is false, I may be disqualified and that any contract made on the strength of this application may be terminated immediately and without notice by MRSDI. If I am the successful contestant in the Teen Miss Rodeo South Dakota Pageant, I understand that my tenure as Teen Miss Rodeo South Dakota and the permission to use that title will not accrue to me unless and until I have that separate agreement with MRSDI entitled "Personal Service Contract For Teen Miss Rodeo South Dakota", the purpose of which is to outline the duties and responsibilities of the parties during my tenure as Teen Miss Rodeo South Dakota.

THE UNDERSIGNED, having entered and participated in the Teen Miss Rodeo South Dakota (TMRSD) Pageant, understands the terms and conditions of this contract, and understands that if designated Teen Miss Rodeo South Dakota, I will be required to enter into this contract as a condition of being so designated. I and my parent/parents make the following statements and agreements with the Miss Rodeo South Dakota, Inc (MRSDI) Board of Directors.

_____ I am a female citizen of the United States of America and reside in the State of South Dakota.

- _____ I will not be less than 13 or more than 18 years of age as of January 1st the year of the Pageant.
- _____ I am of good moral character.
 - ____ I have never been married or pregnant and am a natural born female.

I hereby agree to the following:

- I understand the length of the title of TMRSD shall be from coronation in January 2025, to the following year when the new TMRSD is crowned. During this time, I will not be permitted to represent myself with any other title or compete for any other title unless specifically authorized by the MRSDI Board of Directors.
- During my term as TMRSD, I shall conduct myself in a manner which shall uphold and maintain the dignity and honor of that title. My conduct is at all times to be an example to the public which includes no tobacco or marijuana use, no vaping, drinking of alcoholic beverages, use of illegal drugs or use of offensive or foul language. I will not become pregnant. I will not become engaged or married. I will not cohabitate with someone of the opposite sex unless an immediate family member.
- _____ I agree that as TMRSD, I will dress appropriately, in western attire, complete with crown, banner and buckle during all public appearances.
- I understand I shall be solely responsible for my personal property and physical well-being. I shall not ask for or expect compensation for any injury or loss sustained by me as a result of participating as TMRSD.
- I agree to save and hold harmless the Pageant Director and any or all volunteers associated with the TMRSD Pageant or any functions I attend.
- I understand that I am required to represent my title at rodeos in South Dakota. I will attend a minimum of 5 rodeos during my reign.
- I understand that if I do not comply with the terms and conditions of this Contract, that the MRSDI Board of Directors has the right to remove the title of TMRSD.
- By my signature, I agree to complete the tenure of my term in accordance with the above stated regulations.
- _____ I understand that I am responsible for damage to the traveling crown and traveling chaps.

I understand that I am responsible for collaborating with the reigning MRSD LIW to incorporate my coronation with her coronation event. I shall cooperate with her as the primary focal point of the overall coronation event. I shall not have personal financial gain from the coronation event.
